# SO FAR North Caroliniana Society at Fifty: An Overview

## • PART I

Fifty years ago, two key North Carolina archivists, former Wilson Library NC Collection curator William S. Powell and his successor Dr. H.G. Jones met with two major North Carolina public leaders — UNC System President William Friday of the University of North Carolina and Wachovia CEO Archie K. Davis, the four of them to discuss setting up an NC Collection support fund and a related organization to operate it.

By the time this collaborative meeting (presumably, though *not with certainty*, in Wilson Library on the UNC campus) had ended, these four had mapped out a new NC history and cultural preservation group, to be called the North Caroliniana Society, which Jones, Powell and Louis Connor Jr. would incorporate in September of 1975.

Since that time, the Society has honored with awards and banquet-gatherings the lives and careers of numerous noted North Carolinians; awarded annual prizes to the best North Carolina-focused books; supported the scholarship of numerous A.K. Davis fellows; given an annual award named in honor and memory of William S. Powell to a 3rd- or 4th-year UNC student who has shown an extraordinary interest and related work on the life of the University and/or history of the state; published dozens of imprints about the state; and contributed annually to the further development and expansion of the North Carolina Collection, the largest archive of state-focused publications and materials in the United States of America. The NCS has now become, by the time of its 50th anniversary (September 2025), a public charity (its funds held and managed by the UNC Investment Fund) with over \$6M in investment and quasi-investment funds, whose annual payouts go to support — in addition to the Wilson Library's North Carolina Collection (and the North Carolina Digital Heritage Center there, which grew out of the NCC and which links scores of smaller collections) — such other institutions and enterprises as: *NC Historical Review*; *NC Literary Review*; and NC History Day in early May, traditionally held at the NC Museum of History in Raleigh though, after that

Museum's closing for renovations, now held on the campus of UNC Greensboro. And the NC Division of Archives and History, one of our major beneficiaries, maintains an online collection of free lesson plans concerning North Carolina heritage.

The excellent NCS 2010 publication *What Is Past Is Prologue: The North Caroliniana Society's First Thirty-five Years 1975-2010* celebrates and covers the NCS as we saw it at the time of its 35th anniversary; this document may be found on the society's website: [ncsociety.org](https://ncsociety.org).

So here in *this* report we celebrate and observe NCS doings since then, again seeking to bring our membership up-to-date, this time through the last fifteen years of its history (2010-2025), briefly reviewing important Society initiatives, events and endeavors during this time.

### COMMITTEE ON THE FUTURE

In 2011, seventeen years into his steady and buoyant presidency of the Society, Justice Willis Whichard wisely convened a committee, chaired by H. David Bruton of Moore County, to consider the future of our organization.

We met in Wilson Library on the UNC Campus and made several significant determinations, among them the decision to enlarge our membership from 198 to 250, recognizing the rapidly increasing population of North Carolina itself and wishing to have a diverse, wide-ranging, representative membership comprising leading citizens in the arts, the academy, and the professions (after making this increase incrementally, at ten new members per year for five years, we later felt it necessary to add another 25, and the current NCS membership is limited to 275). A second inspiring goal identified by the 2011-12 committee on the future directed us to find ways to help our public school teachers who are engaged in teaching NC history, geography, literature and lore in 4th and 8th grade classrooms, without prescribing what those ways might be — it would be several years before the key would turn on this grand, broad idea, and virtually everyone would agree that the wait was worth it. This important committee's May 2012 report would be edited by Dr. William Price and coded by Jason Tomberlin of Wilson Library.

### ARCHIE K. DAVIS FELLOWSHIPS

Meanwhile, we continued to support the 1988 research program honoring Society co-founder Archie K. Davis. Fellows doing scholarly work with an essential North Carolina component were selected and funded. As travel expenses increased, the committee making these modest grants totalling \$20,000 made a key decision. Rather than make fifteen or twenty awards of \$500-\$1,000, the committee said: Let us raise the amount of the awards and reduce the number of applicants funded

annually. Now there are \$4,000-\$5,000 grants each year to four or five Davis Fellows. The value of these underwritings are quite clear, for example: Dr. David Silkenat of the University of Florida twice received Davis Fellowships, and his first two books, which grew out of that supported research (*Driven From Home: North Carolina's Civil War Refugee Crisis* (UGA Press, 2015) and *Moments of Despair: Suicide, Divorce, and Debt in Civil War Era North Carolina* (UNC Press, 2011), both received the North Caroliniana Society Book Prize.

## PUBLICATIONS

We continued to publish, and to encourage publication, with a strong imprint series that included not only the speeches of our honorees and their colleagues at our annual meetings, but also several key books about topics not truly dealt with elsewhere, for instance: 1/ Justice Whichard and co-founder H.G. Jones commissioned Glenn Jonas to edit a collection of essays covering *Religious Traditions of North Carolina: Histories, Tenets and Leaders* (2018), which joined the earlier *Hayes: The Plantation, Its People, and Their Papers* (2007) by John G. Zehmer, Jr.; 2/ Whichard and Jones also encouraged Richard Paschal, with Oliver Orr Funds, in the writing of *Jim Crow in North Carolina The Legislative Program from 1865 to 1920* (2021). Whichard, it should be noted, was involved in these publication efforts all while writing his own impressive *A Consequential Life: David Lowry Swain, Nineteenth-Century North Carolina, and Their University* (which was brought out as part of UNC Press's [Albert & Gladys] Coates University Leadership Series, 2024). A revision and update of longtime Deputy Secretary of the N.C. State Archives Dr. Jeffrey Crow's classic 1992 book *A History of African Americans in North Carolina*, commissioned by the Society, was delayed by the cv-19 pandemic and we expect it to be delivered to us for publication in the near future.

Significant and most appreciated editorial work on Society publications over many years has been accomplished by: Dr. H. G. Jones, Imprints Nos. 1-50; Dr. Jeffrey J. Crow, Nos. 51-59; and Lynn Roundtree, Nos. 61-65. Roundtree would later be joined in drafting and editing the 2024 Strategic Plan by NCS board of directors member Eric L. Johnson. We owe immense gratitude to all who have served as editors on our publications.

## WILLIAM C. FRIDAY TEACHER RETREATS

In the autumn of 2012, President Whichard met with Dr. Friday and got his deathbed assent to have a new Society fund named in his memory, the fund to be used for the professional development of NC heritage mastery among selected secondary teachers in the state. And to this end, in the middle of this decade, a most fortunate lunch meeting occurred, bringing Raleigh attorney Martin Brinkley, the Society's secretary-treasurer, together with Lloyd Kramer, Dean Smith Distinguished Professor of History, former UNC faculty chair and at the time Carolina Public Humanities director. What Professor Kramer proposed was simple and highly dynamic: an invitation to the Society to partner with CPH (an



effective intellectual and humanities events outreach unit of UNC Chapel Hill) and to fund an annual public-school teachers retreat in Chapel Hill and elsewhere in the state, aimed at those who taught the North Carolina courses we had noted in the 2011-12 strategic plan. The program would be named in honor and memory of our great friend, fellow NCS member, former Society president, longtime UNC President and incomparable, nationally-renowned educational leader William Clyde Friday: the William Friday Teachers Retreats, to bring thirty teachers per year to Chapel Hill, involve them in seminars led by exemplary scholars and artists from around the state, host them at the Carolina Inn and, all in all, treat those in the group with the respect and dignity they deserve and are too often denied — and try to help keep the best of our best in the profession.

Early in NC State University Professor of English and, as of 2014, NCS President James Clark's tenure, Secretary-Treasurer Brinkley brought this enthralling proposal — which promised to fulfill one of the pre-eminent goals of President Whichard's 2011-12 future of the Society committee, to the NCS board of directors. The response from the NCS board was powerfully positive and CPH's Carolina K-12 went to work at once — Professor Kramer and Christie Norris of Carolina K-12 found the initial response to their 2016 announcement of the first Friday Retreat nothing short of explosive: five hundred teachers applied for thirty spots, exposing a stunning unmet need for professional development among our public school educators.

Where Friday Retreats have met: initially in Chapel Hill and Asheville for a number of years, then in Beaufort (in 2023 and 2024), then Asheville in June 2025 (where the Friday Retreat will be again in 2026). Our 2023 efforts even engendered a Wayne County-area teachers' group to find support and to convene another group modeled upon ours in Beaufort only a month after the NCS Friday Retreat there! During the height of the cv-19 pandemic, with careful planning by Carolina K-12, in consultation with President Clark and the NCS executive committee and with board approval, the Friday Retreat activities were able to pivot and be presented online in a number of well-attended and felicitous ways, rather than risk the sort of in-person gatherings we would have preferred.

## HAYES

We made a most successful, if uncharacteristic, intervention regarding the *ante bellum* home and farm Hayes in Edenton, to wit: the local group seeking to make Hayes (which comprises a phenomenal archive of all papers and material culture ever brought into it) a public-trust holding lacked the funding for an appraisal necessary before Hayes could be proposed to the NC General Assembly for acquisition by the state. The Society provided a modest grant for such an appraisal (\$30,500), and when the state budget passed in November 2021, not only did Hayes thereby become a public holding, to be managed by the Elizabeth Vann Moore Foundation, with help from the Edenton Historical Commission and the Town of Edenton, but also the legislature had added funds to start an interior-waters

passenger-ferry system headquartered in Edenton and serving historic riverports around the Albemarle Sound. The Society's swift yet thoughtful action had both advanced the Hayes goal and coincidentally helped leverage an impressive new, and needed, maritime venture, which came about in part soon *after* an exploratory, proof-of-concept 3-day Albemarle boat tour in 2018, supported by the NC Department of Natural and Cultural Resources and led by NCS members Kevin Cherry (then Deputy Secretary of DNCR); *Exploring North Carolina* host/writer/director Tom Earnhardt; renowned coastal historian David S. Cecelski; and longtime author of books on the natural world of NC's coast, UNC Professor Bland Simpson.

And this was all happening at a time not long before the Wilmington-based environmental group, the NC Coastal Land Trust, was about to be investing in conservation purchases in the immediate area of the mouth of the Chowan River: 1,000 acres along Salmon Creek and 17 acres of remaining Pleistocene seacoast bluffs at Point Comfort on the west banks of that river. Overall, the years just prior to and just after 2020 were an amazing few years of combined historic and environmental preservation in the western Albemarle, of which we played a key part.

## OTHER PROJECTS

A major acquisition for UNC Chapel Hill, aided by Society negotiation and funding, was that of the entire collection of political cartoons created over five decades by celebrated *News & Observer* cartoonist Dwane Powell. Powell, a Distinguished Alumnus of the University of Arkansas-Monticello, was known as a "devastating caricaturist"; he published four collections of political cartoons, won both the Overseas Press Club Award for Excellence in Cartooning and the National Headliners Club Award for Outstanding Editorial Cartoons. The 3,850 items in the Dwane Powell portfolio are now housed in the Southern Historical Collection, Wilson Library, UNC Chapel Hill.

Some smaller projects we have supported, no less important to us and our mission than the larger ones, include: "*NC: A Portrait of Climate Change*," a touring exhibition of photographs organized by Carolina Public Humanities (CPH) as part of its "Climate Change" initiative. The exhibit features images from the Fall 2023 issue of *Southern Cultures* and includes accompanying student photographs. A grant of \$6,481 went to the UNC-Chapel Hill Libraries to have digital prints of hand-colored collotype reproductions of John White drawings professionally framed and matted in order to create a traveling exhibition, first displayed at the Dare County Art Council in Manteo in Spring 2022.

## MEMBERS HONORED

Well worth noting, too, exemplary of all the strong cultural services our members constantly give to our state are these simple facts: just in the past few years, two of our members have been honored by the Governor with NC's high civilian honor, as have many others in times past: in November 2024, first-ever NC environmental attorney; NC Central Law professor; UNC TV conservationist-

communicator Tom Earnhardt received the North Carolina Award for Science; and, in November 2025, author-professor (and soon to be Floodplain Books store co-owner with his wife Mallory in Wilmington) Wiley Cash received the North Carolina Award for Literature. Also in November 2025, NCS Honoree Howard Lee, along with his wife Lillian Lee, were presented with the state's other high honor, membership in the Order of the Long Leaf Pine, at Chapel Hill's Town Hall, where Lee once served as Mayor, first African American mayor in the South since Reconstruction. A few years earlier, David Zucchino garnered his *second* Pulitzer Prize (general nonfiction, 2021) for his revelatory narrative, *Wilmington's Lie: The Murderous Coup of 1898 and the Rise of White Supremacy*. These are but a very few quite recently recognized examples of the significant contributions our members continue to make to the culture of North Carolina.

## EXECUTIVE DIRECTOR

In 2019, as President Clark led the Society toward strengthening our governance, our processes and general organization, the NCS hired its first compensated coordinator, NCS executive director Copie Cain of Raleigh. Cain would soon have help from a Budget Committee, a Grants Review Committee, and from other positive internal changes that would ensure the Society and its officers and directors were well and properly insured, that our assets both financial and physical were well overseen (our investment accounts doubled under President Clark's watch, from \$3M to \$6M!), meaning that strict controls over our accounts in Chapel Hill and Raleigh were the equal of other respected, successful NC non-profits.

## SOCIETY PRESIDENTS AND CO-FOUNDERS

For thirty of the Society's fifty years, two men have served as President, guiding our group with great calm, keenest intelligence and wit, and with vigor and spirit and vision, and, in addition to endeavors and initiatives mentioned above (and so many more), they have presided conservatively over the significant assets we have received and their growth to a level we might not have even imagined only twenty years ago, thus allowing the possibility of our providing stronger support to our collaborators than we could have done in earlier times. For their exemplary leadership and legacies of service, we abidingly honor: the late Justice Willis Whichard (NCS President, 1994-2014, and author of books about both James Iredell and David L. Swain), the only person in N.C. history to have served in both houses of the state legislature and on both N.C. appellate courts, NC Society Honoree in 2016; and Professor and author James W. Clark (NCS President, 2014-2024), who served on the North Carolina State University English faculty, significantly leading NCSU's Humanities Extension and Publications Program and spreading word of North Carolina's multicultural history throughout our public schools, also a member of the North Carolina Literary Hall of Fame, and North Caroliniana Society Honoree-to-be (May 21st, 2026). Both Presidents Whichard and Clark are past recipients of UNC Chapel Hill's Distinguished Alumnus Award.

We pause here, too, to remember, to thank, to honor and to salute the late North Caroliniana Society co-founders William Clyde Friday of Gaston County, N.C.; William Stevens Powell of Johnston County, N.C.; and Houston Gwynne (H.G.) Jones of Caswell County, N.C., all three of whom passed away in the same decade: in 2012 and 2015 and 2018, respectively. Their works *about* and *for* the Old North State, as authors, archivists, curators, historians and educators of the highest order are legion, and our love, respect and gratitude for them and their grand lives is unending.

For our co-founders and our longtime past presidents, only the words of the Preacher, in *Ecclesiastes 44:1-2*, will do:

*Let us now praise famous men, and our Fathers that begat us.  
The Lord hath wrought great glory by them,  
through his great power from the beginning.*

# President's Report: Annual Meeting of the Membership

APRIL 13, 2025, PEMBROKE, NC

We, the North Caroliniana Society, are just over halfway into our 50th year, having been founded in Chapel Hill in September 1975 by our University President, William C. Friday; the president of Wachovia Bank, Archie K. Davis; and two archivist-historians, William S. Powell and H.G. Jones, who, in sequence, served as curators of the North Carolina Collection in UNC-Chapel Hill's Wilson Library for nearly forty years.

From within this collection, and for its benefit, the North Caroliniana Society was born. We are a nonprofit and a public charity, and with the annual earnings of our significant endowment and quasi-endowment funds — now standing at \$5.69M, held in UNC's Investment Fund — we now support not only the North Carolina Collection and the NC Digital Heritage Center, but also related institutions and activities such as the NC Office of Archives and History and the *NC Historical Review* and NC History Day; the William Friday Teachers Retreats planned and presented by the UNC Carolina Public Humanities' Carolina K-12 Program, this year to be held in Asheville; the *NC Literary Review*; and the Archie K. Davis Fellowships Program, which helps fund the NC-focused research of up to four scholars a year. In recent times, our funding for all this has averaged almost \$170,000 a year.

Over the past year, we have instituted more stringent financial practices than we had in the past, better to protect our funds in perpetuity. And we have adopted, as of last October, a new strategic plan, one of whose key recommendations was that we take more opportunities to get out into North Carolina and engage more with our people. All our people.

Indeed, we are most interested in, and hold as a central concern, the history, legends and lore, the stories, all that we can learn and know about how we have all come to be in this shared social and natural environment we call North Carolina: whether one's ancestors crossed the land-bridge 14,000 years ago; came here from the London slums or the Scottish Highlands, or Western Africa, three or four centuries ago; arrived from South America, southern Asia or the southeast Asian Highlands three or four decades ago; or from Nigeria or Ukraine in the last three or four years.

*Got to realize we are one people*, sang the great Jamaican singer-songwriter Bob Marley, and I cannot say it any clearer.

I am pleased and proud that we are met today in Pembroke and Robeson County, in and on the land of the Lumbee, in order to hold our board meeting this morning, our annual meeting now, and, in just a few moments, our honors session, to present a beloved Lumbee elder with the North Caroliniana Society's highest award.

Our board will next meet in Asheville on the third of October, the 125th birthday of Thomas Wolfe, and there we will celebrate our group's 50th anniversary; our next annual meeting will be about this time next year, and all the while twixt now and then we will be looking forward to celebrations across the state of our nation's 250th anniversary of Independence in 2026.

Please let us remember: North Carolina joined the Federal Union in November 1789 *only* after President Washington agreed — at North Carolina's insistence — to add a Bill of Rights to the US Constitution. Let us hold these rights, and those that have come after the original ten, including the essential of birthright citizenship, most dear.

Thank you all for joining our gathering here today on the banks of the Lumber River.

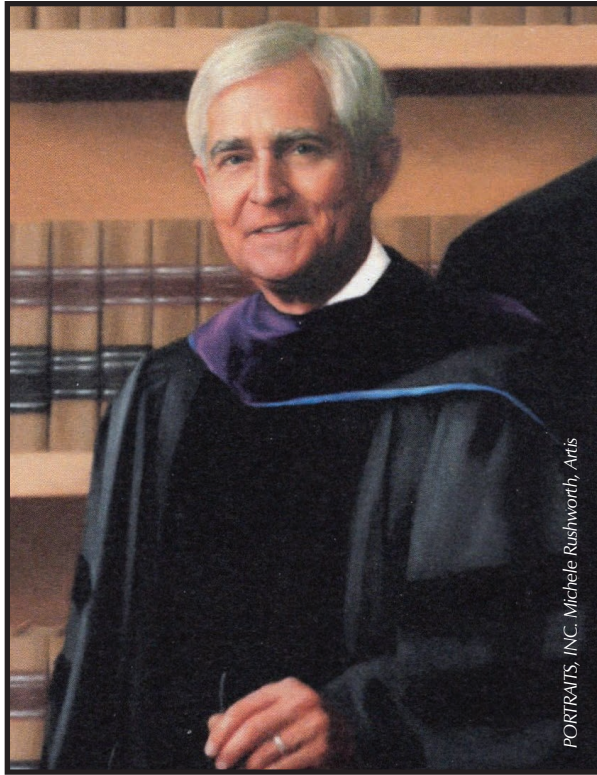

# 2024 NORTH CAROLINIANA SOCIETY BOOK AWARD: George Masa: A Life Reimagined

This year the North Caroliniana Book Award was awarded to Janet McCue and Paul Bonesteel, authors of *George Masa: A Life Reimagined*. During the afternoon's award presentation, Mike Hill, Book Award Committee Chair, shared

*"This year's award recipient, Drew Swanson, is Jack N. and Addie D. Averitt Distinguished Professor of Southern History at Georgia Southern University in Statesboro. Born in southside Virginia, he attended Lees-MacRae College and Appalachian State University before completing his Ph.D. at the University of Georgia. Among his previous books is one about brightleaf tobacco. The present book is a powerful and insightful study of an event in 1870 that led to the so-called "Kirk-Holden War" and the impeachment and removal of Governor W. W. Holden. The murder of state senator John Stephens at the Caswell County Courthouse, along with the mutilation and hanging of Wyatt Outlaw in Alamance County, was the culmination of Ku Klux Klan violence in the region during that period."*

The North Caroliniana Society established the North Caroliniana Book Award in 2003 to recognize annually "the book that captures the essence of North Carolina by contributing powerfully to an understanding of the state." Authors are eligible regardless of residency. However, neither authors nor publishers submit books; instead, a committee privately surveys all books published during the year and chooses the volume that it believes "makes a positive contribution and appears to have the best chance of standing the test of time as a classic volume of North Caroliniana."

# 2025 WILLIAM STEVENS POWELL AWARD: Anna Marie Switzer

English and History Honors Major Anna Marie Switzer '25, a fine storyteller and terrific scholar, served as the archives and communications intern at the Core Sound Waterfowl Museum and Heritage Center at Harkers Island beginning in May 2024. There she produced new oral histories and emphasized community engagement. She has done magazine editorial work and writing for *Walter, Cellar Door*, and UNC's *Journal of History*, and in Earth, Marine & Environmental Studies/English 473 (Fall '24), she created short fiction based on her coastal interviews. "Nobody Cried When He Died" weaves strands of social history from Diamond City's stormy 1890s, the coming of World War II, and the lead character's wartime work at MCAS Cherry Point.

She is from Charlotte, NC, and after graduation, she will be working for Epic Systems in Wisconsin. She hopes to eventually attend graduate school.

The William Stevens Powell Award was established in 2002 by the North Caroliniana Society in honor of the Society's first president, long-time vice-president, and distinguished historian.

The award recognizes a student who, during the student's career at the University of North Carolina at Chapel Hill, has done the most to develop an interest in, and understanding of, the history and traditions of the nation's oldest state university or of the state of North Carolina.

# NATIONAL HISTORY DAY AND H.G. JONES N.C. HISTORY AWARDS

(funding: H.G. Jones Fund)

*N.C. History Day is administered by the N.C. Department of Natural and Cultural Resources and is an affiliate of the National History Day program ([www.NHD.ORG](http://www.NHD.ORG)).*

*Since 1974, the National History Day program has recognized and rewarded students for completing in-depth research and creating original projects that further appreciation and understanding of history.*

*National History Day is a yearlong academic program that engages students in grades 6 through 12 with the discovery of history. Students choose historical topics related to an annual theme, conduct extensive primary and secondary research, analyze and interpret their sources, draw conclusions about their topics' significance in history, and present their work in one of five categories — historical papers, websites, exhibits, performances, or documentaries.*

*Students first compete in one of the seven regional contests across the state. Regional finalists are then invited to attend the state contest. The top two finalists in each category and division are then selected to represent N.C. at the national contest. With guidance from staff and judges, students can improve their projects at each stage of the competition and continue to research and learn.*

The Society began support of National History Day in North Carolina in 1998 when it became the first organization to sponsor special prizes. That support has grown into annual sponsorship of the program, and a contribution of \$15,000 was awarded to The Federation of N.C. Historical Societies as part of continued commitment to provide support to North Carolina students and teachers.

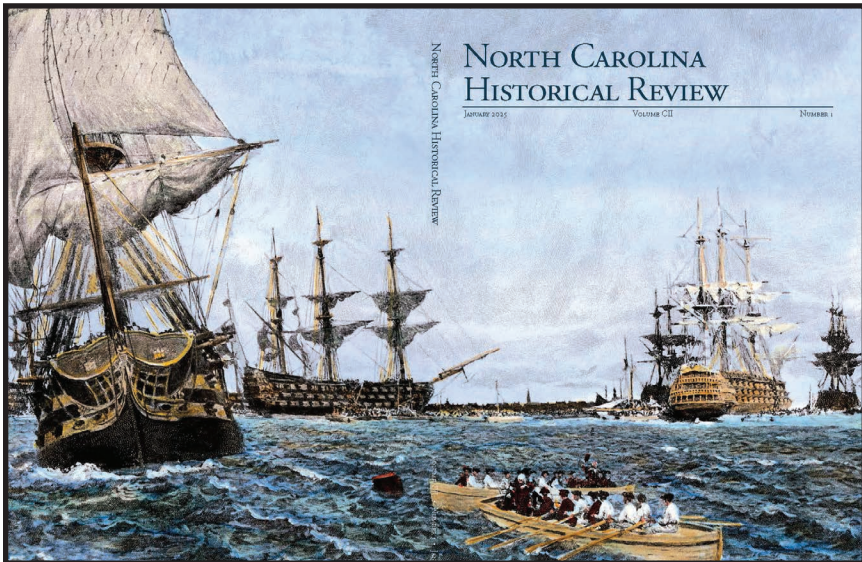

# THE NORTH CAROLINA HISTORICAL REVIEW

(funding: Cashion-Steelman  
and Archie K. Davis Funds)

*Since 1924 the North Carolina Historical Review, published quarterly, has been a definitive source for the study and understanding of North Carolina history. Regular features include carefully researched, handsomely illustrated articles that explore North Carolina and southern history from the colonial period to the present and cover a variety of subjects; reviews of books about state, regional, and national history; an annual bibliography of books pertaining to North Carolina subjects; an annual index; and a listing, printed annually, of theses and dissertations related to North Carolina subjects.*

The Society continued its support of the North Carolina Historical Review, contributing \$14,000 to the N.C. Department of Natural & Cultural Resources to publish the Review. These funds covered approximately 37% of the total cost of printing and fulfillment of Volume 102 of the Review. For Volume 102, 550 copies were printed for over 350 subscribers per issue. The Review is available in electronic form through Ebsco and JSTOR, with some restrictions.

## NORTH CAROLINA COLLECTION, WILSON LIBRARY, UNC-CH

*The North Carolina Collection is dedicated to preserving literary, visual, and artifactual materials illustrating four centuries of the colony and state of North Carolina. The collection comprises three divisions: the Research Library, North Carolina Collection Gallery, and Photographic Archives. The North Carolina Collection, located in historic Wilson Special Collections Library on the campus of the University of North Carolina at Chapel Hill, traces its origins to the founding of the North Carolina Historical Society in 1844.*

*The North Carolina Collection's Research Library has grown to become the largest collection of printed materials related to a single state. The Research Library's holdings are especially strong in printed materials relating to the history and culture of North Carolina, from the earliest accounts of explorers along the North American coast to present-day books and journals. There are extensive holdings of maps, newspapers, and photographs in the NCC and an unparalleled collection of North Carolina literary works.*

*The North Carolina Collection Gallery is an exhibition facility and program with more than 50,000 objects in its care. The Gallery, a component of the North Carolina Collection, provides an immersive experience of North Carolina's history and culture through historic rooms, changing exhibitions, and permanent displays.*

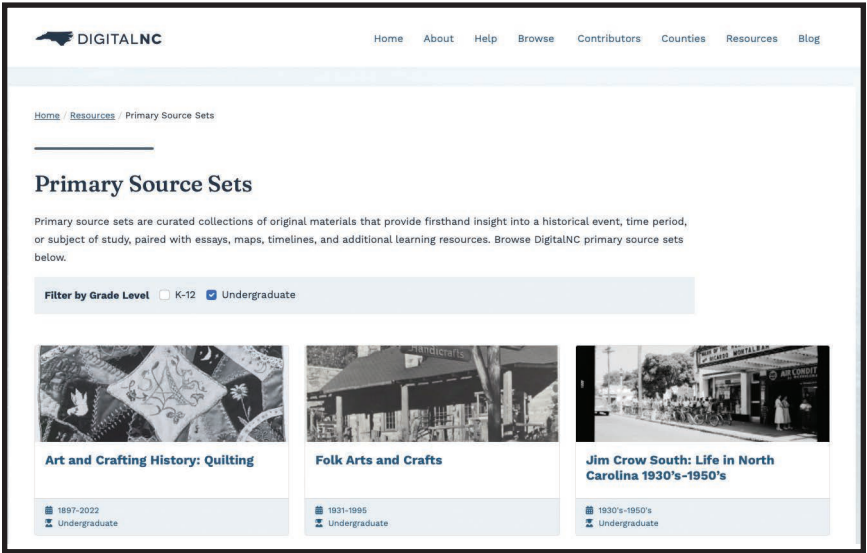
*The North Carolina Collection began collecting photographs in 1929. Today, the North Carolina Collection Photographic Archives contains more than 3,000,000 items, from daguerreotypes to digital photographs. The photographs are descriptive and documentary in nature. They provide a visual record of North Carolina's people, places, and events. Images exist for all 100 of the state's counties.*

# PRIMARY SOURCES TEACHING FELLOWS FOR NORTH CAROLINA HERITAGE

The Society continued its support of the North Carolina Collection, contributing \$34,896 to the University Libraries at the University of North Carolina at Chapel Hill to plan, develop, research, create and publish primary source sets.

The primary source toolkits include links to and images of material from the North Carolina Digital Heritage Center’s (NCDHC) digitized resources as well as guidelines for using these documents in instructional settings. These resources are freely available on NCDHC’s website ([www.digitalnc.org](http://www.digitalnc.org)). These primary source sets will provide university professors and instructor with an easier — but authoritative — way to integrate North Carolina history, literature, and culture in their courses.

# ONLINE EXHIBITS PROJECT

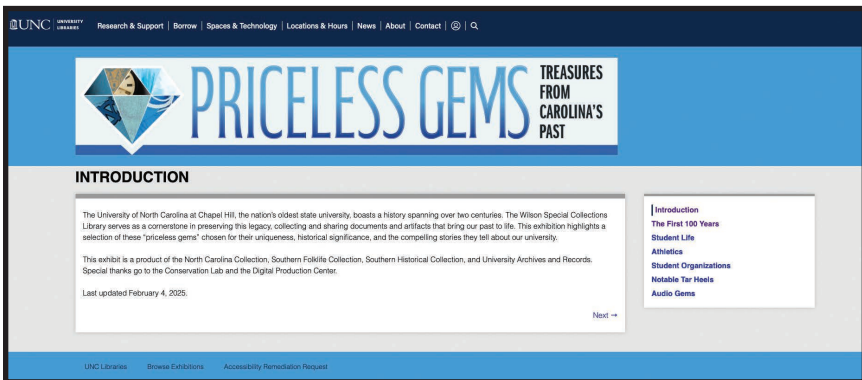

The Society continued its support of the North Carolina Collection, contributing \$17,680 to the University Libraries at the University of North Carolina at Chapel Hill for their ongoing online exhibits project.

With this grant, the NC Collection will continue employment of a curatorial specialist to create online exhibits promoting North Carolina history and culture to web users around the world, and an online database of North Carolina Collection Gallery objects. The North Carolina Collection will continue to share its rich collection of such materials as books, postcards, newspapers, photographs, and three-dimensional objects via online exhibits and online database of objects.

## PORTRAITS OF CLIMATE CHANGE IN NC: SNAPSHOTS AND STORIES OF A TRANSFORMING STATE

(funding: Archie K. Davis Fund)

*The Portraits of Climate Change initiative is a collaboration between the journal Southern Cultures, Carolina Public Humanities, and NC Community Colleges.*

*Carolina Public Humanities (formerly the Program in the Humanities and Human Values) is a unit of the University of North Carolina Chapel Hill College of Arts and Sciences. Carolina Public Humanities serves North Carolina by connecting the University's faculty and resources with communities in our hometown and throughout the state.*

The Society continued its support of the Portraits of Climate Change initiative, contributing \$19,900 to Carolina Public Humanities as part of their continuous commitment to connect the scholars and resources of the University with communities throughout the state, working primarily with community colleges and state historic sites.

Using last year's support, Carolina Public Humanities partnered with Wayne Community College and corresponding faculty liaisons, to feature a talk by UNC-CH Dean of UNC's College of Arts and Sciences and Climate Scientist, Jim White. The event included a photo contest, featuring 7 entries by community college staff, faculty and students.

Plans for future collaborations continue. Three events, possibly in 2026, are expected.

# THE NORTH CAROLINA LITERARY REVIEW

(funding: Archie K. Davis Fund)

*The North Carolina Literary Review (NCLR), produced at East Carolina University, publishes interviews and literary criticism about North Carolina writers and high-quality poetry, fiction, drama, and creative nonfiction by North Carolina writers or set in North Carolina. Our definition of a North Carolina writer is anyone who currently lives in North Carolina, has lived in North Carolina, or uses North Carolina as subject matter.*

*A cross between a scholarly journal and a literary magazine, NCLR has won numerous awards and citations.*

The Society supported the *North Carolina Literary Review*, contributing \$10,000 to East Carolina University to assist in publishing the Review. These funds covered a portion of the cost of the new Digital Editor. There has been an expanded digital reach of the vibrant website and social media platforms (11,000 website users; 37,700 Facebook visitors; 6,000 Instagram visitors).

*In 2016, committed to supporting our state's K-12 teachers, the Society and Carolina K-12, a program of Carolina Public Humanities at UNC-CH, developed the William Friday Teacher Education Initiative, with the goal of equally educating and appreciating our state's hard-working educators through free, quality professional development events and resources.*

### ANNUAL WILLIAM FRIDAY TEACHER RETREATS :

*These unique retreats provide K-12 teachers with three dynamic days to learn about North Carolina's captivating history, literature, and culture in an academic, professional and celebratory retreat atmosphere.*

Each agenda strategically integrates:

- *Presentations on compelling topics from North Carolina history, literature, culture, current events, and more, from engaging scholars, authors & performers in order to deepen participant's content knowledge*
- *Interactive exploration of innovative teaching strategies and coordinating lesson plans to help teachers translate what they learn to their K-12 students*
- *Immersive experiences (tours, museum visits, performances, etc.) that connect to program themes*
- *Exploration of primary sources and online resources from UNC-Chapel Hill Libraries, such as Wilson Library's North Carolina Collection*
- *Time for discussion and collaboration among attending teachers, a rarity in the hectic schedules of educators, but crucial for forging a network of teacher support around the state*
- *Constant affirmation and appreciation of attending teachers and the challenges they face*

The Society continued its support of The William Friday Teacher Education Initiative, contributing \$42,000 to Carolina Public Humanities as part of their continuous commitment to provide support to North Carolina students and teachers.

In late June and early July 2025, Carolina K-12 and the North Caroliniana Society served 40 teachers from 13 counties at the annual William Friday Teacher Retreat. This special group of educators were treated to three full days of learning and fun in Asheville, Lake James State Park, Thomas Wolfe Memorial State Historic Site, and Cherokee, NC. In addition to plenty of pampering at the Grove Park Inn and experiencing a performance of Unto These Hills Outdoor Drama,

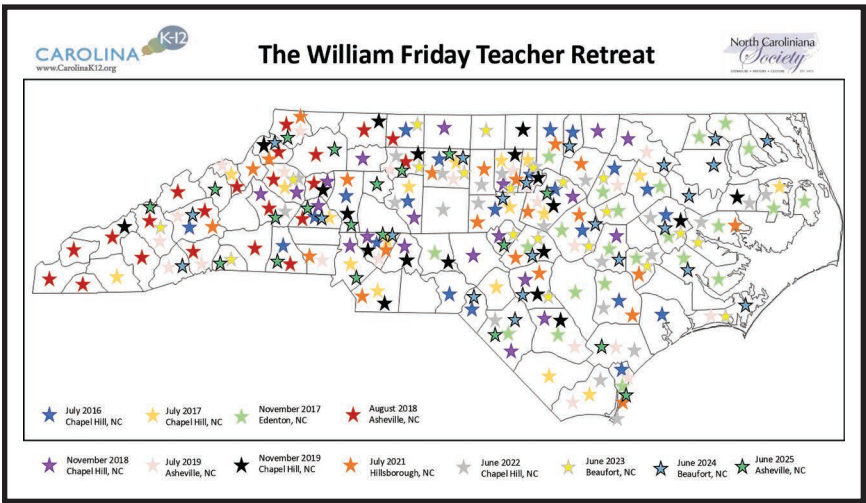

To date, 436 public school teachers from 86 NC counties have participated in the 12 annual William Friday Teacher Retreats. These teachers will reach a minimum of 61,040 K-12 students each school year. Since 2022, an additional 670 North Carolinians have been reached through other events sponsored by the Society in partnership with Carolina K-12.

# Minutes of a Meeting of the Board of Directors

OCTOBER 30, 2024  
WILSON LIBRARY, CHAPEL HILL, NC

Pursuant to notice duly given, President Bland Simpson. called a meeting of the Board of Directors of the North Caroliniana Society, Inc. to order at 12:16 p.m. on Wednesday, October 30, 2024.

Present in addition to the President were Vice President Terry Roberts, Secretary-Treasurer Patrick S. Wooten, President *emeritus* Willis P. Whichard, Executive Director Copie Cain, and the following members of the Board of Directors: Margaret D. Bauer, Tom Earnhardt, Georgann Eubanks, Emily Williamson Gangi, Rebecca Godwin, Anna R. Hayes, Eric L. Johnson, C. Edward Teague III. Also present were *ex officio* directors Vicki Rovine, Director of Carolina Public Humanities and Jason Tomberlin, Chair & Facilitator, Archie K. Davis Fellowship.

President Simpson welcomed those present to Wilson Library. He welcomed new Board members Richard Stevens (unable to attend); Lisa Gregory, Interim Curator of the North Carolina Collection (unable to attend); and Jason Tomberlin, Chair and Facilitator of Archie K. Davis Fellowship Committee. All members were asked to introduce themselves.

On motion of Mr. Roberts, seconded by Mr. Earnhardt, the minutes of the Board of Directors meeting, held on April 24, 2024, in Chapel Hill, were approved as distributed.

On motion of Mr. Teague, seconded by Ms. Eubanks, Board actions via email from June 13, 2024, to October 15, 2024, listed in Appendix A, were ratified.

Executive Director Cain introduced Ms. Susan Glendenning of Maddison & Caison for presentation of the draft review of the 2023-2024 Review Report and Financials and Form 990. Ms. Glendenning pointed out a few items related to the Society's financials: market gains during the fiscal year, amounts available for operations, and investments in the UNC Investment Fund.

On motion of Mr. Teague, seconded by Mr. Earnhardt, the Reviewed Financials and Form 990 for the year ending June 30, 2024, were accepted as reviewed and circulated, subject to the change in one footnote, if appropriate.

Secretary-Treasurer Wooten shared an updated Conflict of Interest Policy (Appendix B). On motion of Mr. Roberts, seconded by Mr. Teague, the policy was approved.

Executive Director Cain shared that the Society's new insurance broker, Indaco Risk Advisors, is serviced by her son, Quentin Cain. Indaco Risk Advisors has prepared a proposal for additional coverage, for the Society's consideration. President Simpson asked Ted Teague and Patrick Wooten to gather a committee to meet with the agent and present to the Executive Committee for future consideration.

President Simpson asked for a five-minute recess.

President Simpson commented on, and the Board discussed, the effectiveness of the collaboration with Carolina Public Humanities, which created the William Friday Teacher Education Initiative.

Executive Director Cain pointed Board members to the Programs, Grants, and Projects report distributed by email and provided at the meeting. The report includes last year's support of Archie K. Davis Fellowships, History Day and the H.G. Jones Awards, the North Carolina Historical Review, North Carolina Collection's digitized gallery exhibits project, and the William Friday Teacher Initiative, including an annual in-person teacher retreat in Beaufort. Executive Director Cain also reviewed the grants approved, soon to be paid out, for the Society's fiscal year ending June 30, 2025.

President Simpson asked Ms. Rovine to comment on the Carolina Public Humanities (CPH) projects: Friday Retreat and the Portraits of Climate Change. Ms. Rovine acknowledged the work Paul Bonici has been doing and shared that CPH has hired Cori Greer-Banks to take the position of the Director of Carolina K-12, previously held by Christie Norris. Ms. Rovine thanked the Society for their continued support.

President Simpson shared that Interim Curator Lisa Gregory's report for the North Carolina Collection and Deputy Secretary Darin Water's report for the Office of Archives & History and their projects will be shared via email.

Secretary-Treasurer Wooten shared Board member Kevin Cherry's request for the Society and/or the Board to visit Edenton. Mr. Earnhardt inquired if there is a way to support Western North Carolina, possibly holding a Board meeting there. President Simpson asked for a motion to amend the agenda to include a New Business section to discuss these matters (adding it just above the 50th Anniversary section). On motion of Mr. Earnhardt, seconded by Ms. Eubanks, the addition to the agenda was approved.

President Simpson asked for comments and suggestions regarding the spring 2024 event at Carolina Inn which was followed by discussion.

President Simpson recognized Mr. Earnhardt as recipient of the 2024 North Carolina Award for Science, the state's highest civilian honor.

President Simpson reminded Board members that Dr. Jo Ann Chavis Lowery was to be honored with a Society Award this fall but the event had to be postponed. President Simpson presented Dr. Jo Ann Chavis Lowery as the 2025 Society Award honoree. On motion of Ms. Gangi, seconded by Ms. Bauer, the nominee was approved. Executive Director Cain announced Sunday, April 13,

2025, as a tentative date for the next Board meeting and Awards celebration.

President Simpson shared the Nominating Committee's plan to meet in February 2025 to review the membership roster and nominations. Executive Director Cain shared that Membership Nomination forms are included in the Annual Appeal letter mailing. Members are invited to make nominations any time during the year.

President Simpson asked Mr. Johnson to present the 2024 Strategic Plan which was put together by Eric Johnson and Lynn Roundtree, reviewed and edited by the Executive Committee, and previously shared with all Board members and the Strategic Plan committee, via email, for comments and questions. Mr. Johnson shared how helpful the day-long working session was to the process. Ms. Gangi asked for an amendment to the Membership & Engagment section, to better reflect the ethnic and racial diversity of the state. On motion of Mr. Teague, seconded by Ms. Gangi, adoption of the 2024 Strategic Plan, as to be amended by Mr. Johnson, was approved.

President Simpson asked to move to New Business, which includes ideas discussed at previous various meetings:

- Connecting NC Collection with ECU collection
- Dedicated (full or part-time) communication person for the Society (Rovine)
- Podcast, TV (Johnson)
- "NC for new North Carolinians"
- Publication – ecology of historic sites (Clark)
- Thomas Wolfe cabin (Simpson/Roberts)
- Marrying natural and cultural resources (Earnhardt)

Discussion ensued regarding Society involvement: How items of interest (social support and financial support) are reviewed and accepted by the Society.

Mr. Teague referenced the Strategic Plan, regarding the Grant Review Committee's responsibilities. President Simpson asked Board members on The Grant Review Committee to plan to review and report back to the Executive Committee with recommendations regarding:

- Maintain a core stable of long-term, committed partnerships and dedicate nondiscretionary resources to sustain them.
- Study how the Society can entertain one-time projects or pilot collaborations and set consistent guidelines for awarding those funds (a possible *catalyst/opportunity fund*).
- Continue to establish consistent criteria (with the Grant Review Committee) for soliciting and evaluating funding proposals, offering a clear rationale for how all funded projects contribute to the Society's mission and report on the impact of such expenditures.

President Simpson presented a plan to have a Board meeting in Edenton. Ms. Eubanks shared that the 50th Anniversary is an opportunity to celebrate 50 years and celebrate initiatives. Board members discussed a fall 2025 meeting in Western

2. That the signature of the NCS Executive Director, Copie Cain (noted as Key Executive on the accounts), the NCS Secretary-Treasurer, Patrick Wooten, or the NCS Vice President, Alice Cotten, be authorized to access all accounts and funds of the Society held at Wells Fargo Bank, N.A.;
3. That authorized access to all accounts and funds of the Society held at the University of North Carolina Foundation Investment Fund shall require the signatures of two of the following persons: NCS President Bland Simpson; NCS Vice President Terry Roberts; or NCS Executive Director Copie Cain;
4. That the Executive Director and the Secretary-Treasurer, in furthering the interests of the Society, be authorized to make expenditures from the Society's funds in amounts consistent with the Society's budget approved by the Board of Directors; provided, however, that expenditures in excess of that amount may be made upon approval of a majority of the Executive Committee of the Board of Directors; provided, however, that no expenditures shall contravene the internal financial control policy adopted by the NCS Board of Directors;
5. That the Archie K. Davis Fellowship Committee, appointed by the Executive Committee of the Board of Directors, be authorized to evaluate applications for Archie K. Davis Fellowships and make awards, reporting to the next meeting of the membership.

APPENDIX B  
NORTH CAROLINIANA SOCIETY  
CONFLICT OF INTEREST POLICY

• ARTICLE I  
PURPOSE

This conflict of interest policy is designed to foster confidence in the integrity of the NORTH CAROLINIANA SOCIETY (the “Organization”) and to protect the Organization’s interest when it is contemplating entering a transaction (defined below) that might benefit the private interest of an insider (defined below). The policy also addresses situations in which any of these insiders may directly or indirectly benefit, except as the Organization’s employees or members of its board or other governing body, from the Organization’s disbursing of funds, and shall include actions to be taken by the Organization or the insider, or both, to avoid conflicts of interest and the appearance of impropriety.

• ARTICLE II  
DEFINITIONS

The following are considered *insiders* for the purposes of this policy:

1. Each member of the Organization’s Board.
2. The Executive Director, Chief Financial Officer, or any person with the responsibilities of any of these positions.
3. Any *key employee* who (a) has responsibilities or influence over the organization similar to that of Board members; or (b) manages a program that represents 10% or more of the activities, assets, income, or expenses of the organization; **or** (c) has or shares authority to control 10% or more of the organization’s capital expenditures, operating budget, or compensation for employees.

*Interest* means any commitment, investment, relationship, obligation, or involvement, financial or otherwise, direct or indirect, that may influence a person’s judgment, including receipt of compensation from the Organization, a sale, loan, or exchange transaction with the Organization.

A *conflict of interest* is present when, in the judgment of the Board, an insider’s stake in the transaction is such that it reduces the likelihood that an insider’s influence can be exercised impartially in the best interests of the Organization.

*Transaction* means any transaction, agreement, or arrangement between an insider and the Organization, or between the Organization and any third party where an insider has an interest in the transaction or any party to it.

### • ARTICLE III PROCEDURES

#### 1. *Duty to Disclose*

Each insider shall disclose to the Board all material facts regarding his or her interest in the transaction, promptly upon learning of the proposed transaction.

#### 2. *Determining Whether a Conflict of Interest Exists*

With regard to an insider, the Board shall determine if a conflict of interest exists. The insider(s) and any other interested person(s) involved with the transaction shall not be present during the Board's discussion or determination of whether a conflict of interest exists, except as provided in Article IV below.

#### 3. *Procedures to Address a Conflict of Interest*

The Board shall follow the procedures set forth in Article IV in order to decide what measures are needed to protect the Organization's interests in light of the nature and seriousness of the conflict, to decide whether to enter into the transaction and, if so, to ensure that the terms of the transaction are appropriate.

### • ARTICLE IV REVIEW BY THE BOARD

The Board may ask questions of and receive presentation(s) from the insider(s) and any other interested person(s), but shall deliberate and vote on the transaction in their absence. The Board shall ascertain that all material facts regarding the transaction and the insider's conflict of interest have been disclosed to the Board and shall compile appropriate data, such as comparability studies, to determine fair market value for the transaction.

After exercising due diligence, which may include investigating alternatives that present no conflict, the Board shall determine whether the transaction is in the Organization's best interest, for its own benefit, and whether it is fair and reasonable to the Organization; the majority of disinterested members of the Board then in office may approve the transaction.

### • ARTICLE V RECORDS OF PROCEEDINGS

The minutes of any meeting of the Board pursuant to this policy shall contain the name of each insider who disclosed or was otherwise determined to have an interest in a transaction; the nature of the interest and whether it was determined to constitute a conflict of interest; any alternative transactions considered; the members of the Board who were present during the deliberations on the transaction, Those who voted on it, and to what extent interested persons were excluded from the deliberations; any comparability data or other information obtained and relied upon by the Board and how the information was obtained;



and the result of the vote, including, if applicable, the terms of the transaction that was approved and the date it was approved.

• **ARTICLE VI**  
ANNUAL DISCLOSURE AND COMPLIANCE  
STATEMENTS

Each insider of the Organization shall be provided a copy of this policy.

• **ARTICLE VII**  
VIOLATIONS

If the Board has reasonable cause to believe that an insider of the Organization has failed to disclose actual or possible conflicts of interest, including those arising from a transaction with a related interested person, it shall inform such insider of the basis for this belief and afford the insider an opportunity to explain the alleged failure to disclose. If, after hearing the insider's response and making further investigation as warranted by the circumstances, the Board determines that the insider has failed to disclose an actual or possible conflict of interest, the Board shall take appropriate disciplinary and corrective action.

• **ARTICLE VIII**  
ANNUAL REVIEWS

To ensure that the Organization operates in a manner consistent with its status as an organization exempt from federal income tax, the Board shall authorize and oversee an annual review of the administration of this conflict of interest policy. The review may be written or oral. The review shall consider the level of compliance with the policy, the continuing suitability of the policy, and whether the policy should be modified and improved.

ExOfficio and Board members, connected to grantee organizations, were asked to leave the room for further conversation. On motion of Mr. Roberts, seconded by Ms. Gangi, the Grants Review Committee report was approved.

President Simpson called on Mr. Wooten to review the proposed budget for the 2025-2026 fiscal year, listed in Appendix E. Discussion followed and three amendments were proposed:

- USES: General/Operating Expenses: Insurance - change to \$5,000 (with Executive Committee approval for final insurance coverage proposals)
- USES: Continued Support: Teacher Retreats – change to \$42,000
- USES: Special Programs & Projects: remove Carolina Public Humanities – Mapping Project for \$28,250

On motion of Mr. Earnhardt, seconded by Mr. Roberts, the Budget, as amended, was approved.

President Simpson led a discussion on choosing the 2026 Society Award winner. Board members were asked to share names with Executive Director Cain before the October Board meeting so a decision could be made.

President Simpson shared that the fall Society Board meeting would be a two day meeting in Asheville, NC – Thursday, October 2 to Friday, October 3, 2025.

The meeting was adjourned at 12:15 p.m.
